HUNTING, TRAPPING, USE OF FIREARMS

ARTICLE I

Hunting, Trapping, Use of Firearms  
[Adopted 11-21-32]

- S 27-1. Hunting, trapping and use of firearms restricted.
  - A. No person or persons shall at any time hunt, pursue or kill with a gun, any wild animals, fowl or birds, or take with traps or other devices any fur-bearing animals, or engage in hunting, trapping or setting traps or using firearms of any description within the corporate limits of the Village of Attica.
  - B. The owner of property within the corporate Village of Attica, may, in order to eliminate pests upon his own property, trap and kill such pests, by his agents or servants, upon permission being granted by the Village Board therefore;

that said permission is to be evidenced by a permit in writing, signed by the Village Clerk, upon the instructions of the Village Board. **[Added 8-19-35]**

**S 27-2. Violations and penalties.**

Any person or persons who violate any of the provisions of this ordinance shall be guilty of a misdemeanor and punishable by a fine not exceeding the sum of twenty-five dollars (\$25.) for each offense, and in case of the nonpayment of such fine, by imprisonment in the county jail not exceeding one (1) day for each one dollar (\$1.) of such fine, in the discretion of the court or Magistrate.

**S 27-3. Violations constitute disorderly conduct.**

It is further enacted and ordained that any violation of the provisions of this ordinance shall be considered disorderly conduct, and that the person violating the same shall be a disorderly person.

**S 27-4. When effective.**

This ordinance shall take effect after due publication and posting as provided by law.

**ARTICLE II**  
**Airguns, Crossbows, Slingshots and Firearms**  
**[Adopted 3-6-1899]**

**S 27-5. Discharge prohibited.**

No person or persons shall discharge an airgun, crossbow, slingshot or firearm of any description in the Village of Attica.

**S 27-6. Violations and penalties.**

Whoever shall violate any provision of this ordinance shall for each offense forfeit and pay the sum of five dollars (\$5.) for the use of said village, to be recovered in an action in the name of the village with costs.

**S 27-7. When effective.**

This act shall take effect on the first day of April, 1899.
